**ORDER EXTENDING THE CORPORATE EXISTENCE
OF THE CENTRAL CHARLOTTE COUNTY DRAINAGE DISTRICT**

THIS CAUSE, having come before the Court on Central Charlotte County Drainage District's Motion to Extend the Corporate Existence of the Central Charlotte County Drainage District and the Court having heard from the parties and otherwise being advised in the premises, it is HEREBY ORDERED AND ADJUDGED:

1. The Central Charlotte County Drainage District ("the District") is a public agency created as a water-control district pursuant to the requirements of Chapter 298, of the Florida Statutes, by that certain Order entered in the above-styled cause on January 6, 1966, with respect to property located in Township 41 South, Range 23 East, Charlotte County, Florida.

2. The Florida Legislature adopted Chapter 69-932, Laws of Florida, which ratified, confirmed, and approved the January 6, 1966, Order.

3. This Court extended the existence of the District through January 5, 2026, by that certain Order entered December 14, 1994.

4. The District owns and operates drainage facilities within its jurisdictional boundaries, including road swales, canal systems, and other drainage structures, to provide stormwater drainage and flood control to the properties within its jurisdictional boundaries.

5. It is in the best interest of the landowners within the District's boundaries for this Court to extend the District's corporate existence for an additional thirty (30) years to January 5, 2056.

6. The Court has jurisdiction to extend the corporate existence of the District pursuant to section 298.01 of the Florida Statutes, and this Court's order, dated December 14, 1994.

7. The Central Charlotte County Drainage District shall be and shall continue to be a public corporation of this State for an extended term of thirty (30) years commencing on January 6, 2026, through January 5, 2056.

8. The Clerk of Court shall retain this as an active Court file during the pendency of the corporate existence of the Central Charlotte County Drainage District.
